

Greens/EFA counterproposal to the "single" External Instrument for the post-2020 Multiannual Financial Framework (MFF)

Covering foreign affairs, enlargement, neighbourhood, development and defence

6.06.2018

General remarks:

- The Greens/EFA Group agrees with the Commission and the EEAS that compared to the current financial architecture for External Action, the future structure should be simpler and more coherent.
- However, contrary to the Commission, the Greens/EFA group rejects the idea of the Commission to merge 12 external financing instruments in one "External Action" instrument in which 20% of the unallocated funds are possibly earmarked for "migration".¹
- The future financial architecture needs to strike the balance between predictability and flexibility. We see room for merging 6 external action instruments and 5 development cooperation instruments. We stress the importance of maintaining separate instruments for the most important Union policies: Enlargement (IPA), neighbourhood (ENI), development (merger of DCI and EDF), human rights and democracy (EIDHR) and civilian conflict prevention/crisis response (IcSP).
- As regards Union support for closer military cooperation between Member States, the Greens/EFA Group rejects the idea to use scarce EU budget resources for supplementing Member States military spending and instead proposes maximal pooling of national funds in an off-budget European Peace or better: Military/Defence Facility.
- Overall, the Greens/EFA Group believes that the next MFF provides an opportunity to correct the trend of a foreign and development policy driven by short-term interests, particularly migration control. Over the past years, we have witnessed the creation of a large number of trust funds and facilities, which are beyond parliamentary control. Migration is a global phenomenon that will remain a challenge, as well as an opportunity, and should be addressed by instruments, that are shaped in ordinary, transparent and democratic co-decision processes. Time is over for non-democratic ad hoc solutions via "emergency" trust funds that deliver dubious results.
